Update on VicTAG QUM projects

. Medication safety notice distribution system

A system has been developed to enable disseminating safety notices via the VicTAG communication network to all Victorian VicTAG member hospitals. The procedure and draft notice will be sent to all Directors of Pharmacy for information.

To date, the project steering group has received a few suggestions for safety notices but have agreed that as these are not new products or alerts have already been distributed, a notice is not warranted. The Project Officer (Sue Wright) is currently collating information from hospitals who have completed the action plan from the DoH Oral Chemotherapy Alert which will assist hospitals that have not completed this work to inform strategies to meet the criteria.

2. Current practice and barriers to implementation of user applied labelling in Victorian hospitals

Many hospitals have completed this audit and returned information to the project group. This data will be collated and participating hospitals will receive their data and the total Victorian data for comparison.

The collated data will be reviewed by the project group and common themes, barriers identified. If considered appropriate, feedback will be discussed with the Commission, and will also be used to assist hospitals with implementation.
