## VicTAG 2022 Membership Fees

VicTAG membership fees for 2022 are now due. The fee structure is listed below, with a 10% increase applied to level 1, and a 5% increase to level 2 memberships; level 3 members remain unchanged from last year.

#### Collaboration with HealthShare Victoria


### **Current Projects Update**

#### Safe Handling of Hazardous Medicines

This VicTAG project, led by **Bishma Jayathilaka** from the Peter MacCallum Cancer Centre and a team of contributors from the Parkville Precinct hospitals, has now been completed and published. The project aimed to develop a Victorian Framework for the Safe Handling of Hazardous Medicines. The framework provides definitions for hazardous medicines, a recommended classification and the personal protective equipment required for handling. Click here to access the framework. # Framework to Standardise Smart Infusion Pump Medication Libraries and Guide Integration with Electronic Medication Management Systems (EMMS)

This VicTAG project, led by **Madonna Khreish** from Monash Health with stakeholders from metropolitan and rural health services, is well underway. The framework will include guiding principles to developing, implementing and ongoing review of smart pump medication libraries, as well as provide guidance on aligning and integrating smart pumps with EMMS to allow bidirectional interoperability. The group have also developed a minimum data set with common adult and paediatric infusions.



## Framework for Anticoagulants' Clinical Decision Support Tools in Electronic Medication Management Systems

**Viviane Khalil** from Monash Health is leading this project to improve anticoagulant prescribing and use. Anticoagulant clinical decision support (CDS) build data has been collected from all members of the stakeholder group. These are currently under review and are being mapped to the various steps of the medication management pathway. Feasibility of building new anticoagulant CDS is being explored. Writing of the first draft of the framework is also underway.

#### **VicTAG QUM Group**

The VicTAG QUM group provides a support network for VicTAG member hospitals to identify issues which increase the risk of medication error and determine practices to improve medication safety. The group meets every 2 months, currently via videoconferencing, and has an active discussion forum.



The Medication Safety Alerts Program has produced 12 alerts in the last year, covering a broad range of topics including the safe handling of hazardous medicines, adrenaline (epinephrine) autoinjectors for anaphylaxis, summary posters on insulins and medications for Parkinson's, as well as alerts on medication shortages.
